

## **Privacy Policy**

IndiceFX understands and values their clients and visitors. We recognize the seriousness and your concerns regarding the confidential personal information we obtain on various stages of our relationship. Protecting your confidential information is the most important aspect of our business. We pledge to protect that information and ensure that it remains private. The information in this notice summarizes the categories of personal information that we collect about you, how that information is handled, and how we protect that information.

### 1. Collection of Information

“Non-public personal information” is information about you that we obtain in connection with providing a product or service. This may include such information as your name, address, Social Security number, and/or financial institution account numbers. We may collect non-public personal information about you from the following sources:

- Information that you provide to us, such as on applications or other forms;
- Information about your transactions with us, our affiliates or others; or
- Information from others, such as other IndiceFX users, consumer-reporting agencies, banks, and employers.

Our site’s registration forms may require users to give us contact information (e.g., name, phone no. and email address). We use such user contact information from the registration form to send the user information about our affiliate companies and other products & services. User contact information is also used to contact the user when necessary. Users may opt-out of receiving future non-essential mailings and SMSs. However, users may not opt-out of receiving emails and SMSs, which in the sole opinion of IndiceFX are necessary for the administration and maintenance of your IndiceFX account or other accounts, usernames, blog sites, account(s) and memberships that you might have established with one or more of our affiliate companies your “Accounts”). Additionally, we use your IP address to help diagnose problems with our server, and to administer our Web site. The confidentiality of your non-public personal information will continue to be maintained consistent with this privacy notice even if you decide to close your Accounts or if your Accounts, become inactive, or if you otherwise cease to do business with us.

### 2. Additional Information

To better serve you, we sometimes collect additional information about our users from third party sources. This information will also be subject to this privacy policy as well as applicable law.

### 3. Personal Information Changes

Personal information changes, such as changes of email address, may be made at any time by signing in to your account and changing your user profile. We believe that your privacy should never be compromised. At the same time, we want to offer you the array of products and services you need to accomplish your goals. We believe we can do both by adhering to the provisions of this policy. We do not sell customer (current or former) information to third parties. Any information shared by us is done so to fulfill our legal requirements, to facilitate regulatory compliance by our affiliated companies, or to provide you with the products and services you have requested. We require that all third parties with whom we share your information agree to keep it confidential. We share selected information under certain conditions:

- (1) We disclose information about you to a variety of third parties to bring you financial and/or other services as necessary to fulfill these third party service agreements; we share information as part of normal business operations and as part of normal legal and or regulatory processes to the extent required by our service partners and/or government and regulatory entities;
- (2) We may share limited information with third parties to assist in the analysis of customer demographics, business analysis and marketing strategies; these third parties must agree to strict confidentiality provisions to assure the protection of your information;
- (3) We may share opt-out e-mail addresses with third-parties who send communications on our behalf in order that they may eliminate their receipt;
- (4) We may retain a service to contact opt-in customers on our behalf to perform Account closure analysis. Additionally, we may invite you to share your contact information from time-to-time through the IndiceFX platform or with third party research organizations. Although we don't share information with other third party offer providers, we occasionally distribute to our customers select third party offers we feel would be beneficial to our customers. We may also purchase or receive lists of non-customers but we will not redistribute such lists.

### 4. Information Security

IndiceFX has security measures in place to protect against the loss, misuse and alteration of the information under our control. We cannot, however, guarantee against unauthorized access to your information, although we take reasonable measures to protect your Information from unauthorized access. We restrict access to information about you to those employees and authorized agents who need to know that information in order to provide

products or services to you. We maintain stringent physical, electronic and procedural safeguards to maintain the confidentiality of your information.

When you access our Account holder areas, you are required to provide your username and your password (login details). Do not share your login details with anyone and change it frequently. Password changes can be made at any time by signing in to your account.

Access to your information is granted only to employees and third-party service providers who need it to perform a specific service. Our service providers are contractually obligated to keep your personal information confidential. You are also encouraged to read the separate privacy statements of our service providers.

## 6. Cookies

Non-Personal Information is collected, inter alia, through the use of cookies.
